Deer Lodge Curling Club Facilities Rental Agreement

- 1) The renting part agrees to assume full financial and legal responsibility for any damages that result to the premises, property and persons of Deer Lodge Curling Club, guests and neighboring properties as a result of the event of which the renter has booked the Deer Lodge Curling Club facility. A damage deposit will be required and paid to the Deer Lodge Curling Club no less than seven days prior to the function. Such deposit will be refunded to the renting parties within seven days of completion of the function providing that there is no damage caused by the renter or his/her guests as determined by an inspection of the premises by Deer Lodge Curling Club and the renting party on the day after the event.
- 2) Set-up of tables and chairs for the rental event will be the responsibility of the renter in conjunction with the DLCC Bar and or Banquet staff.
- 3) Post event clean-up of decorations and facility is the responsibility of the renter. If left unattended a surcharge pf \$50.00 will be levied to the renters.
- 4) Banquet meals, breakfasts, and luncheons must be catered by the Deer Lodge Curling Club caterers, unless otherwise agreed.
- 5) A non-refundable deposit of 50% of the facility rental will be paid to the Deer Lodge Curing Club at time of reservation. The balance of the agreed charges will be due and payable no later than the date of the event.
